**WAIVER**

Accident Waiver and Release of Liability and Registration Agreement

By signing below, you agree, warrant and covenant as follows:

1. Authority to Register and/or to Act as Agent. You REPRESENT AND WARRANT to The Tree House Child Advocacy Center (Tree House) that you have full legal authority to complete this event registration, including full authority to make use of the credit or debit card to which registration fees will be charged. In addition, if you are registering third parties, you represent and warrant that you have been duly authorized to act as agent on behalf of such parties in performing this event registration. By proceeding with this event registration, you agree that the terms of this Accident Waiver and Release of Liability and registration agreement shall apply equally to you and to any third parties for whom you are acting as agent.
2. Compliance with Children's Online Privacy Protection Act (COPPA). You represent and warrant that, in compliance with COPPA, you are over thirteen (13) years of age, and that if you are registering a child under fourteen (14) years of age you are the parent of such child, and do hereby consent to the collection of such child's personal information by TREE HOUSE.
3. Acknowledgment of RISKS. I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The RISKS include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released (as stated below), from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I CERTIFY that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person. I CERTIFY that I will properly wear a CPSC approved bicycle helmet. I understand and CERTIFY that I must obey all laws of the State of Maryland which may apply to my activities during this event, especially traffic laws. All traffic signals, devices, and other traffic rules apply to me during this event. Unless instructed to the contrary by a law enforcement official, I must comply with all traffic regulations.

I understand that if I start my ride after my assigned group and route sweep have left, I am no longer a participant of The Tree House Tour de Cookie ride and I assume ALL RISKS ENTIRELY ON MY OWN. I also understand that amenities of The Tree House Tour de Cookie ride may not be available to me.

4. Acknowledgment of WAIVER. I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and my participation in this event and related activities, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) WAIVE, RELEASE AND DISCHARGE from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me THE FOLLOWING ENTITIES OR PERSONS: TREE HOUSE, Montgomery County Health and Human Services, Montgomery County Government, Johns Hopkins University, all sponsoring or co-sponsoring companies or individuals related to the Event, together with their officers, directors, managers, members, shareholders, successors and assigns, and any and all governmental and tribal agencies and any and all event sponsors, event beneficiaries, event directors, event volunteers, and each of their respective directors, officers, employees, volunteers, representatives, agents, successors, and assigns; (B) INDEMNIFY AND HOLD HARMLESS the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my participation in this event and any related activities.

I hereby CONSENT to receive MEDICAL treatment which may be deemed advisable in the event of injury, accident and or illness during this event.

I understand that at this event or related activities, I and/or my children may be photographed. I AGREE to allow all of these photos, videos or film images to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and or assigns.

This AWRL shall be construed broadly to provide a RELEASE and WAIVER to the maximum extent permissible under applicable law.

You AGREE that exclusive jurisdiction for any dispute with TREE HOUSE resides in the courts of the State of Maryland and you further agree and expressly consent to the exercise of personal jurisdiction in the courts of the State of Maryland in connection with any dispute including any claim involving TREE HOUSE or its affiliates, subsidiaries, employees, contractors, officers, directors, telecommunication providers and content providers.
